- **I.** Subject of the bid is a sale of property in the area of the business zone "Međimurje business park "(former military training ground "Gmajna") in Čakovec and Pribislavec registered in:
- land register sheet no. 4404, cadastre municipality Čakovec, land registry plot no. 1134/53/1 (identical to cadastral plot nr. 1703/1), by nature infertile land, overall surface area of 380 395 m<sup>2</sup> (ca. 38 ha) and

Foreign bidders are required to furnish a bid security in the amount of **25,000.00 EUR** to the Međimurje County foreign currency account in Međimurska bank d.d. Čakovec, V. Morandinija 37, no: 2392007-1800020004, SWIFT: MBCKHR2X, svrha uplate: "POSLOVNI PARK MEĐIMURJE".

Bid securities furnished by bidders who have not been selected shall be released within 8 days as of the day of the selection of the most successful bidder, in its nominal amount without interest, while the amount of bid security shall be calculated towards purchase price as far as the successful bidder is concerned.

The bidder who fails to sign the contract upon being chosen as the most successful bidder, or the bidder who fails to pay the whole sum of the purchase price within scheduled date, shall forfeit the right to the bid security retrieval.

## IV. Contents and enclosures to the bid

- V. Bidder shall submit a conceptual proposal, i.e. a site development plan and the manner of use of the respective property which shall encompass mixed, commercial and industrial activities. The development plan should also include the property which is not for sale, registered in land register sheet no. 2272, cadastre municipality Čakovec, land registry plot nr. 1134/2, overall surface area of 10 8637 m² intended for social activities (Polytechnics, secondary schools, incubation centre and similar) which makes an integrated complex with the mentioned property.

The seller is willing to accept proposals which shall enable optimal utilisation of the site provided that the proposal does not differ considerably from the set guidelines and the interest of Međimurje County.

The bidder will be obliged to develop the area in cooperation with the Međimurje County and the Regional Development Agency of the Međimurje County – REDEA ltd. Therefore, the bidder shall propose the form of such collaboration.

- **VI.** Apart from the price and date of payment, other selection criteria are: compatibility of the site development plan and the manner of use of the property with the interests of the Međimurje County, anticipated deadlines for the development of the site (by stages and as a whole), anticipated number of new jobs from the beginning of investment to the finalisation of the project (by stages).
- VII. The bidder shall submit the written bid along with the enclosures in Croatian language in a sealed envelope to the following address: Međimurska županija, Ruđera Boškovića 2, 40 000 Čakovec specifying the bid reference: "Ponuda za kupnju nekretnina POSLOVNI PARK MEĐIMURJE". If the successful bidder fails to sign the contract within 7 days as of the final decision on sale, it will be considered the bidder is refraining from the purchase. Property transfer tax and other costs incurred by the bidder related to signing of the contract, translation costs, notarisation costs and costs relating to the transfer of ownership shall be borne by the buyer.
